1. The participant(s) named or his/her legal guardian(s), has read the class description(s) and understands the nature and content of the activities involved, and any potential dangers incidental to engaging in such activities.
2. The participant(s) named or his/her legal guardian(s) certify that the participant is in excellent physical health and has no medical, psychological, or mental conditions which have not been disclosed to West Coast Fusion Elite Performance Training Center Homeschool Academy Management or Ownership.
3. The participant(s) named or his/her legal guardian understands that there is an inherent risk of accidental physical injury in some or all of the activities offered throughout the program and agrees that the risk of injury is assumed by his/her legal guardian(s), in consideration for being permitted to participate in a West Coast Fusion Elite Performance Training Center's Homeschool Academy program.
4. # ENROLLMENT REGISTRATION AGREEMENT

**REGISTRATION FEE:** I understand that each semester a **non-refundable, Registration Fee of \$24.95 - \$99.95** shall be paid in advance to enroll my child and reserve space. I understand that I may only guarantee my child's enrollment for Fall/Spring by paying this fee no later than 30 days prior to start of semester. In instances of agency reimbursement, the Registration Fee is to be paid according to the applicable terms.

**TUITION and MODIFICATIONS CONDITIONS: \$12.50 - \$99.00 per hour** is the current tuition rate for most academic classes in the Fusion Elite Homeschool Academy. I understand that rates may be subject to change without notice as conditions require. Outside specialty courses may charge a higher hourly.

**PAYMENT OF TUITION:** I understand that tuition is paid with Charter voucher or personally where voucher is not accepted. Appropriate alternate Tuition Fees such as Summer Camps, Spring Break Camp, Winter Camp, Full Day Camps, before and after hours program tuition, specialty STEM classes and upgrade programs must be paid at the time of enrollment.

**LATE OR UNPAID TUITION:** If payment in full is not received when due, I agree to pay a **late payment fee of \$25 per week** that tuition is not received. All late fees are subject to change without notice. I understand that if my account is delinquent for any reason for more than two weeks, I may be asked to withdraw my child from the Fusion Elite Homeschool Academy until my account is made current. The school cannot guarantee a child's spot will be held when a child is withdrawn due to non-payment of tuition. **Any unpaid tuition fees may be sent to a third-party collection agency if it cannot be handles with a reasonable time frame between Fusion Elite and the delinquent party. Any legal fees incurred during the collection of unpaid tuition will be added to the collection amount.**

**CHARGES AND PROCEDURE FOR LATE PICK-UP:** Fusion Elite Homeschool Academy ends at 2:30 pm. Monday through Friday all year, except for holidays with a 15 minute grace period for pick up. I understand that if I fail to pick up my child by the **scheduled closing time of 2:45 pm, I may be charged a late fee of \$5 per every 15 minutes or portion of fifteen minute period, per child**, until the child is picked up.

**DISCOUNTS:** I understand that if I have more than one child enrolled attending from my immediate family, a 10% discount from the usual tuition fee is offered to all subsequent family members. These discounts are also available to those accounts when full tuition is paid in advance. **Ask your program director for details.** Discounts are not applicable on any other fees or services, Agency Co-Pays, or special program promotions cannot be combined with any other discount or promotion.

**RETURNED CHECKS:** I understand that a **processing fee of \$35.00** will be charged to my account for all checks which are returned for any reason, and this fee is in addition to any charges that my bank or financial institution may charge me. I understand that any non-sufficient funds checks will be automatically resubmitted electronically up to three times. I further understand that once a check has been processed electronically, the check is no longer negotiable and will not be returned. **If more than two checks are returned within a six month period, I will be required to pay in full by an alternate method of payment for the next six month period.** The maximum fee allowed by state law will be charged for all returned checks. I am responsible for the principal amount plus all returned check fees.

**DAILY SIGN-IN AND SIGN-OUT:** I agree to sign my child out every day using the school's attendance procedure. If I neglect to do so, **I may be charged a maximum additional fee of \$5.00 per missed sign-in.** I understand that as a minor, my child is not permitted to sign him/herself in for class. I understand that I am required to enter the school to drop off and pick up my child and that I must escort my child to and from the designated drop off and pick up areas and check in with a Fusion staff member each day.

**ILLNESS:** I understand that I will be notified should my child become ill during the day, and that I will pick up my child promptly, or make arrangements for an authorized emergency contact person to pick up upon such notification. If my child is exposed to or contracts a contagious disease, I agree to notify the school and I understand that my child will be re-admitted according to the Re-admission Criteria in the Parent Handbook. **Temperatures will be checked upon arrival daily! Any temperatures over 100.4° will be placed into isolation and must be immediately picked up.**

**AT WILL TERMINATION:** Fusion reserves the right in its sole discretion to dismiss or terminate any member, parent, student or client from the program for any reason they deem appropriate for such action. Reasons for dismissal could be but not limited to fighting, theft, verbal abuse, purposely misleading staff, providing false information, making false accusatory and slanderous comments about the company, its staff or other members. Dismissal may also occur for purposefully starting or engaging in derogatory rumors or gossip about the program, its staff, its members or owners.

**SPECIAL NEEDS:** I understand that Fusion Elite Homeschool Academy is not qualified to offer special needs instruction and attention and that students needing such services should consult their Charter for an appropriate and adequate location to provide them quality service.

**WITHDRAWAL FROM PROGRAM:** I understand that I must provide a **30 day written notice of withdrawal** from the program. If this notification is not provided, I agree to pay all tuition and fees for an additional 30 days, whether or not my child attends. I understand that when my child is withdrawn, s/he will only be eligible for re-admission based upon space availability and all other enrollment criteria. If my child is selected for re-enrollment, I will be required to complete an entire new Enrollment Agreement at the current rate and pay a new non-refundable Registration Fee at the current rate. If there is an outstanding balance (including tuition or fees) when my child was withdrawn, I will be required to bring my account current prior to completing a re-enrollment application. I understand all fees (Tuition, Registration or Activity) are non-refundable.

**HOLIDAYS:** I understand that the school is closed on the following holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Day, as well as either Martin Luther King, Jr. Day or President's Day. **Fusion Elite Homeschool Academy does not charge for holidays and closures.**

**ABSENCES/VACATIONS:** I agree to inform the school immediately if my child will be absent on any day. Fusion Elite Homeschool Academy does not currently charged for taking time off as long as you meet the minimum attendance requirements for the semester and have given advanced notice on all planned vacations or absences. I also understand that if I withdraw my child during a vacation, I will be required to pay a new non-refundable registration fee upon return.

**ALL POLICIES & STATE REGULATIONS:** I understand that the above policies are not an all-inclusive list of policies, and that my child, my family members, authorized agents and I are bound by state child care regulations, the Parent Handbook, and all other company policies, which may be modified at any time, without notice. I also understand that the child care regulations of the state in which my child attends may prevail over these policies when the state regulation is stricter. I further understand that my continued enrollment constitutes my acknowledgement of, and agreement to abide by, all Policies and state regulations.

**COVID19:** I am choosing to allow my son/daughter to participate in the Fusion Elite Performance Training Center Fun Club After School Enrichment Program. I understand that there are risks associated with my participation and I fully accept and release the owners, staff, vendors, assigns, associates from any and all responsibility related to any likelihood of contracting COVID-19 during these visits. I fully confirm that my son/my daughter have not tested positive for COVID-19 nor do I have any symptoms currently related to the COVID-19 infection. **QUARANTINE:** If any signs or symptoms of COVID19 are recognized or thought to be recognized by a staff member, we will error on the side of caution and require that the student be quarantined for a minimum of 5 days at which time they will need to take a COVID19 test and submit a notice of negative in order to return. If no COVID test is taken, then the student must stay quarantined for a minimum of 14 days prior to returning symptom free.

**WAIVER:** This waiver and release applies to this visit and any and all subsequent visits to the Fusion Elite Performance Training Center.
